I. Approval of Minutes & Agenda

- A. December 9 minutes approved.
- B. February 3 minutes approved after the addition of Claudia Close, Jan Hiley, and Nancy Stucker to attendees.
- C. Agenda approved.

II. Action Items

- A. Approval of new Council reps
 - Michelle Chao (HASS) and Bridgete Clark (HWPEA) approved as new council reps.
- B. Approval of CFT Convention delegates
 - ➤ John Govsky, Jefferson Hancock and Maya Bendotoff approved to serve as Convention delegates.
- C. Approval of funding for t-shirts
 - EB has recommended that we start with about 100 t-shirts, at an approximate cost of \$1,150. Donations of \$5-\$15 will be made per shirt.
 - Council approved spending approximately \$1,150 for the order and production of the shirts.

III. Leadership Teams

- A. Solidarity & Community

- iv. March for California's Future: March 5-April 21 walk from Bakersfield to Sacramento to highlight the need to protect and restore quality education for all Californians.

IV. Negotiations

A. Interest-based bargaining is used in CCFT/District negotiations. Rather than focusing on a particular solution to a specific problem, teams discuss interests (or concerns behind an issue), and look to develop solutions based on criteria. Handout distributed. Trying to problem solve.

Council developed the following interests as pertains to reemployment preference:

- i. Cohesive faculty with less divisiveness
- ii. Health and wellness of all members
- iii. Opportunity for advancement
- iv. Job security
- v. Increased stability of staffing
- vi. Consistent & predictable income
- vii. Continuity
- viii. Acknowledge the role of both adjunct & full-time play in the quality of education

- ix. Increased job security linked to seniority
- x. A clear and fair process for addressing competing needs
- xi. Clarity and transparency of assignment
- xii. Recognition of longevity
- xiii. Quality of education
- xiv. Retention of excellent faculty
- xv. Rigorous hiring & evaluation for all faculty (Claudia Close noted that the hiring process for adjuncts has recently been relaxed).
- **B.** Layoff Process

Some faculty members may receive layoff notices. Stroke Center, EOPS, DSPS, and Counseling would most likely be the areas affected.

Process: Deadline for notices of intent to layoff: March 15. Final deadline for approving layoff notices: May 15. In between these two dates CCFT will represent faculty members in layoff hearings. Please have affected faculty members contact Maya.
