- III. Budget Update, Paul Harvell
 - A. Review yellow sheet—PH's estimates:
 - i. This year we will run approx. \$3m deficit, can be covered by the net ending balance (NEB)
 - ii. Next year, approx. \$3.4m deficit (+ \$2.7m if tax initiative does not pass, i.e., 5% of Cabrillo's budget)
 - B. District's official expected estimate \$5m (\$2.5m can come from NEB)
 - C. Question: where do student fee increases come in?
- IV. Student Success Task Force Recommendations
 - A. Legislature set to move forward with several recommendations
 - 1. Reprioritizing matriculation, incoming assessments and education
 - 2. Resources to colleges to fund above
 - 3. BOG waiver limited to 110 units (lifetime) and must have ed. plan
 - 4. Strengthening Chancellor's office
 - 5. Student success scorecard for accountability
 - B. Review green sheet, 8 major recommendations from final report—see 80 page report for full detail.

- V. Presentation on for-profit colleges, John Govsky
 - A. Industry growing fast
 - B. 86% of funding comes from our tax dollars in the form of federal student aid
 - C. Wall street dominates industry
 - D. Cost of for-profits to students is much higher—huge debt, higher loan default rates
 - E. High student withdrawal rates
 - F. Low instructional expenses per student—astronomical profits

- VI. Student Engagement: State Funding for Education, ideas from faculty:
 - A. Work with student clubs—AGS, Democrats, etc.
 - B. Use the first class to educate about the budget—see handout "Why you couldn't get into classes"
 - C. Tell students about endorsements (e.g., CCFT)
 - D. Share info about projections of will happen if tax initiative fails
 - E. Encourage students to educate themselves on education budget
