II. Reports

- a. CCEU, Alta in lieu of Stephanie Stainback:
 - i. CCEU is negotiating with the district; their proposals:
 - 1. PERS reduction to decrease till employee picks up entire 7%, eliminate PERS college contributions for new employees.
 - 2. Cap of longevity pay at 10%.
 - 3. Health benefits cost share—low HMO for employee only (retirees only).
 - ii. Stephanie Steinback's job is due to be cut in phase three.
 - iii. Comment: CCUE members are taking big cuts and wishes CCFT would show more support of them.
- b. CFT Convention
 - i. Six of our members attended, and left energized and entertained.
 - ii. Info pieces:
 - San Mateo: union endorsed non-incumbents for the board, DAs brought charges for misuse of school resources and equipment for political purposes.
 - Santa Monica College (SMC) proposed two-tiered tuition proposal (lexus pathway), student protesters were pepper sprayed, SMC Board suspended for fear of bad publicity, expected to reemerge.
- c. CCFT Elections, Debora Bone and John Govsky
 - i. Openings listed and timeline proposed.
- d. Adjunct Chair
 - i. Report adjunct eNews, coffee breaks
 - 1. Suggestions: practical content not just information (e.g., job lists or other services).

- ii. Unemployment filing workshop!
- e. President's Report, Paul Harvell
 - i. Discussion about option of each division nominating its representatives—this would be helpful in terms of accountability.
- f. MBCLC Dinner 4/27: John, Debora, Sadie, and Meredith will go.

III. Contract Ed

- a. Eric Hoffman distributed summary of benefits documents from contract.
- b. Note differences for PT vs. FT.
 - i. Suggestion: go back to earlier time when adjunct stipend actually covered cost of insurance for employee.

IV. Leadership Teams Leadership teams met and report back:

- a. Budget & Negotiations
 - i. District proposal: freeze step and column, share benefits increases.
 - ii. Wanted to go in using IBB, which would involve not going in with positions but interests and finding middle ground (drawback: everyone comes in with extreme positions to meet halfway).
 - iii. Better to look at the numbers and see what is sensible.
 - 1. We will look at college budget, e.g., the share that goes to faculty, NEB.
 - a. NOTE: our concessions will maintain NEB not save jobs.
 - 2. We will look at other schools (almost all have frozen step and column).
 - iv. Re: the possibility of concessions:
 - 1. We will keep faculty informed and if we need to have a discussion with faculty over summer we call an open forum.
 - 2. Timeline: there is very little time, which works in our favor.
 - 3. We won't make decisions during summer without faculty input.
 - 4. The faculty survey will give CCFT ideas about what to prioritize.
 - 5. This is a multi-year process for the district; whatever they don't get this year they will push for next year. We should think about what concessions we might consider.
 - 6. If the tax initiative doesn't pass we are probably taking an across-the-board pay cut.
- b. Solidarity & Community
 - i. Tax petitions are due today. Cabrillo faculty and retirees gathered 600+ signatures!
 - ii. COPE Drive to run through May.
 - COPE letter out beginning of May—educating members on tax initiative, corporate deception initiative, and governing board elections.
 - 2. Phone banking the week of May 14
 - a. Sign in sheet for phone banking sent around (dates May, 15, 16, 17).
- c. Faculty Input & Dialogue
 - i. Burrito Bash, Friday May 5.
 - 1. Bring your own chair, dishes, other faculty members, and an appetizer or dessert (leaning toward appetizers).
